-		2. BNMC under one pretext or other delayed the project and for over 20 months out of a 36 months' contract and hence work for the project could not be commenced.
		3. Since the work for the aforesaid project could not be started due to reasons not within the control of the company within 1/8th of the stipulated time for completion of work, the

		company requested BNMC to either close the contract and refund the Earnest Money Deposit and the performance Guarantee, as agreed under the Tender Agreement or provide the company a price escalation on overall project cost.
		4. However BNMC issued a show cause notice and arbitrarily threatened to invoke and encash the bank guarantee.
		5. Hence, the company filed the petition under Section 9 of the Arbitration and Conciliation Act, 1996 against BNMC to prevent the invocation of Bank guarantee as interim relief under Section 9 of the Arbitration and Conciliation Act, 1996
